# **Course Catalog Description**

This course is designed to provide students with a basic understanding of the principles of prokaryotic and eukaryotic genetics. Emphasis is placed on the molecular basis of heredity,

chromosome structure, patterns of Mendelian and non-Mendelian inheritance, and the genetics of human disorders. In this course, students will demonstrate an understanding of the patterns of inheritance by analyzing how DNA, RNA, and proteins contribute to the genotype and phenotype of an organism. Students will apply this knowledge, along with their understanding of classic inheritance patterns, to a range of human genetic disorders.

### **Course Prerequisites**

Knowledge of Biology I & II or their equivalent is recommended to be successful in this course.

At the completion of this course students will be able to:

- 1. Explain the structure of genetic information and how it is translated into the functional molecules of living organisms.
- 2. Identify, describe and distinguish between common patterns of inheritance.
- 3. Apply probability concepts to solve genetics problems.
- 4. Apply genetic principles to produce family pedigrees that illustrate inheritance patterns.
- 5. Explain the basis of mutations and their potential consequences.
- 6. Describe the techniques used in genetic screening and testing.
- 7. Evaluate current ethical, legal and social issues associated with human genetics.
